1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Tanzania **Procurement Journal Issue No ISSN 1821-6021, Vol.IX-No 24 dated 14, June 2016.**

The Kibaha Town Council received a loan from the World Bank towards the cost of **Urban Local Government Strengthening Program (ULGSP)**, and it intends to apply part of the proceeds of this **Loan** to cover eligible payments under the contract for **Construction of Kibaha Bus Stand and provision of Streetlight in Kibaha Town Council.**
3. The **Kibaha Town Council** now invites sealed Tenders from **eligible National Contractors registered or capable of being registered With CRB in Class Three (3) and above in Civil Works** for carrying out the **Works in Kibaha Town Council.**
