CONSTRUCTION OF KIBAHA BUS TERMINAL ADMINISTRATION BUILDING(BUS TICKETING OFFICES, WAITING LOUNGE AND ADMINISTRATION BUILDING)

1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Tanzania **Procurement Journal Issue No ISSN 1821-6021, Vol.IX-No 34 dated 22, August 2017.**
2. The Kibaha Town Council received a loan from the World Bank towards the cost of **Urban Local Government Strengthening Program (ULGSP) and UNCDF**, and it intends to apply part of the proceeds of this **Loan** to cover eligible payments under the contract for **Construction of Kibaha Bus Terminal Administration Building (Bus Ticketing Offices, Waiting Lounge and Administration Building in Kibaha Town Council.**
3. The Kibaha Town Council now invites sealed Tenders from **eligible National Contractors registered or capable of being registered With CRB in Class Four (4) and above in Building Works** for carrying out the Works in Kibaha Town Council
4. Tendering will be conducted through the National Competitive Bidding procedures specified in the Procurement Regulations, 2013-

Government Notice No.446 and are open to all Tenderers as defined in the Regulations unless otherwise stated in the Tender Data Sheet.

5. Tenderers should note that to qualify for award of the contract, they are required to meet minimum qualifying criteria as provided in Section III of the Bidding Document. Tenderers must also be able to demonstrate that, in the capacity as a prime Contractor, they should have successfully completed **at least Three (03) projects of similar nature and complexity within the last 5 (Five) years**. Tenderers are required to provide full and detailed particulars of their financial capability to perform such works and to demonstrate that they have experienced key personnel with appropriate qualifications. Tenderers should also note that the works must be completed within **Six (6) months** and that they are required to provide detailed particulars of all items of equipment and plant that they deem necessary to deploy for the timely completion of the works. **Tenderers who are proven non-performers need not apply as they will be disqualified.**
6. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of the Tender Board Kibaha Town Council, P. O. Box 30112 KIBAHA – Pwani Region, from 08.00am – 03.30 p.m** working hours on Mondays to Fridays inclusive except on public holidays.
7. A complete set of Tendering Document(s) in **English and additional Sets** may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 9 below and upon payment of a non-refundable fee of **Tanzanian shilling One Hundred Thousand Only (100,000.00.)** Payment should either be by **Cash, Banker's Draft, or Banker's Cheque**, payable to **Town Director, Kibaha Town Council, P. O. Box 30112**
8. All Tenders must be accompanied by a **Tender Securing declaration** in the format provided in the Tendering documents unless otherwise stated in the Tender data sheet
9. All Tenders in one(1) original **plus two copies(2)** properly filled in, and enclosed in plain envelopes must be delivered to the address : **Secretary of The Tender Board, Kibaha Town Council, P. O. Box 30112 KIBAHA,PWANI** at or before **Wednesday 04th April,2018**

at 10:00 a.m .Tenders will be opened promptly thereafter in public and in the presence of Tenderer's representatives who choose to attend in the opening at **the Kibaha Town Councils' Conference Hall**

10. A combined site visit and pre-bid meeting will be held on **29th March, 2018 at 09:00 a.m hour's local time** at the offices of Kibaha Town Council. The visit will commence at the Council Office.
11. Late Tenders, portion of Tenders, electronic Tenders, and Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
